Monthly fee for children who are not entitled to the government's childcare funding:

The Nursery is open **Monday-Friday 8am – 6pm**, offering sessions of 10 hours of childcare per day on a year-round basis. The Nursery is open **50 weeks** of the year, which entitles your child to **11.4 hours or 22.8 hours of funded hours per week**.

**Fees are payable for 52 weeks of the year. Fees are calculated by subtracting the funded hours from the total hours of attendance per week. The unfunded hours X the hourly rate X 50 weeks + the cost of the 2-week closure in August (normal attendance days per week). This is then divided into 12 equal monthly payments, plus the monthly consumable charge.**

**Fees are due on the 1<sup>st</sup> of each month. Should we receive payment later than the 1<sup>st</sup>, a late charge will be incurred.**

**Fees are reviewed annually, and parents are given two months' notice before the increase takes effect in April.**

Consumable charge is for Suncream, Calpol, Nappy Sacks, Nappy Cream, All Meals, Snacks, Baking Ingredients, Extra Curricular Activities, Graduation, Christmas Activities, Celebrations and Parties. The consumable charge is only chargeable for the funded hours.

Parents have the option of opting out of paying the consumable charge (A month's notice will be needed). Should a parent opt out, alternative arrangements regarding meals, snacks, extracurricular activities etc will be made between the nursery and the parent.

Parents who wish to take up just their funded childcare hours can do this and can take up 20 hours per week over 2 days (**10 hours per day 8am-6pm**). One of the days taken must be either a Monday or a Friday, and the other day offered will be subject to availability. Parents can utilise the remaining 2.8 hours of funding per week at another provider, provided it is open for the same number of weeks per year, should they choose to spread their funding across two providers.

Parents do not have to take up additional childcare hours in addition to the 20 hours of funding per week but can request these should they want to.

## **Admissions**

We operate on a waiting list, and siblings have priority over the waiting list. Admissions are also based on the date the child was added to the waiting list and the start date they require.

If a place is offered to you, a £50 Non-Refundable Registration Fee will need to be paid to secure the space.

**This is not applicable to children attending the funded hours only.**
